

OFFICIAL CALL
Mass Meeting
of the City of Fairfax Republican Committee
of the Republican Party of Virginia

As Chairman of the City of Fairfax Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, James L. Kaplan, do hereby issue this call for a Mass Meeting to be held in the Council Chambers of City Hall at 10455 Armstrong St., Fairfax, VA 22030, starting at 8:00 PM local time on March 18, 2010 for the following purposes:

1. Electing up to 80 Delegates and an equal number of Alternates to the Republican Party of Virginia 11th Congressional District Convention to be held in West Springfield High School, 6100 Rolling Road, Springfield, VA 22152 on May 22, 2010 at 11:00 AM for the purposes of electing a Congressional District Chair. Each unit is entitled to one (1) Delegate Vote per (500) Republican votes for Governor and President at their last election, so that The City of Fairfax Republican Committee is entitled to 16 Delegate Votes;
2. To elect a unit chairman and up to 79 members to the unit committee;

And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of the City of Fairfax under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Prefiling is required for all candidates at said mass meeting, for election for Unit Chairman, Members of the City of Fairfax Republican Committee, and/or as a delegate or alternate delegate to the 11th District Convention. Prefiling must be made on the Official Prefiling Form and mailed to the Nominations and Credentials Committee Chair, David Kailey, PO Box 1363, Fairfax, VA 22038-1363, or delivered in person to Dr. Sandra M. Chase at 10418 Whitehead Street, Fairfax, VA 22030. All prefiled forms must be received not later than 6:00 PM on March 11, 2010 and accompanied by any fees as noted below (postmark shall not count). Faxes and e-mailed documents are not acceptable.

Prefiling for participating in the City of Fairfax Republican Party Mass Meeting is encouraged, but not required.

If no more than one candidate prefiles for election to the unit chairman, that candidate will be declared elected. If fewer than the maximum number of Delegates that the City of Fairfax is entitled to send to the District convention prefile, all properly prefiled candidates shall be deemed elected. If fewer than the maximum number of candidates for membership to the City Committee are prefiled, then all properly prefiled candidates shall be deemed elected. If all prefiled candidates are deemed elected, then no mass meeting will be held.

Prefiling/Registration Fees

Unit Chair - \$250.00 Prefiling fee.

City of Fairfax Republican Committee member - \$20.00 annual dues, first year to be paid at prefiling.

Delegate/Alternate Delegate to the 11th District Convention - \$20.00 registration fee

There is no registration fee to participate in this mass meeting. *A voluntary fee of \$10.00 is requested to help defray the costs associated with the Mass Meeting*
