

OFFICIAL CALL
Mass Meeting
of Dickenson County Republican Party of the Republican Party of Virginia

As Chairman of the Dickenson County Unit of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Randy Davis, do hereby issue this call for a Mass Meeting to be held at Dickenson County Court House; Main Street; Clintwood, VA 24228, starting at 9:00 a.m. local time on March 13, 2010 for the following purposes:

1. Electing up to 110 Delegates and an equal number of Alternates to the Republican Party of Virginia 9th Congressional District Convention to be held in Fort Chiswell High School; #1 Pioneer Trail; Max Meadows. VA 24360 on May 22, 2010 at 10:00 a.m. for the purposes of nominating and electing a Congressional District Chairman, Also, nominating a Republican candidate for the House of Representatives. Each unit is entitled to one (1) Delegate Vote per (250) Republican votes for Governor and President at their last election, so that Dickenson County Republican Party is entitled to 22 Delegate Votes;
2. To elect a unit chairman, 1st vice-chairman, 2nd vice-chairman, treasurer, secretary and members to the unit committee

And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party after March 1, 2004, or in the last five years, whichever is more recent.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

There will be a voluntary registration fee of \$5.00 to participate in this mass meeting. Please make checks payable to Dickenson County GOP. There will also be a voluntary fee of \$5.00 for those attending as Delegates/Alternates to the Ninth Congressional District Republican Conventions. Please make checks payable to the Ninth District Republican Committee.
