

**OFFICIAL CALL FOR A MASS MEETING**  
**of the CHARLOTTE County Unit of the Republican**  
**Party of Virginia**

As chairman of the Charlotte County committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Anthony Pasciuta Jr., do hereby issue this call for a Mass Meeting to be held at the Charlotte County Courthouse, in Charlotte Ct. House, Virginia, starting at 7:30P.M., local time on Thursday, March 25, 2010 for the following purposes:

1. To elect a unit chairperson, vice chairperson, treasurer, secretary and members to the unit committee;
2. Electing up to 55 delegates and an equal number of alternates to the Republican Party of Virginia, 5th CONGRESSIONAL DISTRICT Convention to be held at Hampden Sydney College, Johns Auditorium, Hampden-Sydney, Virginia on Saturday May 01, 2010, beginning at 11:00 A.M. for the purpose of Electing a District Chairman. Each unit is entitled one (1) Delegate voter per 500 Republican votes for Governor and President at their last election, so that Charlotte County is entitled to 11 delegates votes;
3. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Charlotte County under the laws of the Commonwealth of Virginia, Regardless of Race, Religion, National Origin, or Sex, who are in accord with the principles of the Republican Party and who , if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its Mass Meetings, party canvasses, conventions, primaries, encompassing their respective election districts. **Please be advised that proxies are never allowed at a mass meeting, party canvass or convention. This is also expressly prohibited by national party rules.**

Filing Requirements

All Candidates for Nomination for Chairperson, Vice Chairperson, Treasurer and Secretary, shall pre-file a "Declaration of Intention To Seek Nomination for Office", which must be received by Anthony Pasciuta Jr., Chairman of the Charlotte County Republican Committee, 9838 Craftons Gate Hwy, Drakes Branch, VA. 23937, by mail or in person, no later than March 15, 2010 by 7:00 pm, as per the bylaws of the Charlotte County Republican Committee. Postmarks do not govern. Candidates to become a Delegate to the 5<sup>th</sup> District Convention, may pre-file in the same manner, or be present at the mass meeting to register as a delegate. Emails are **not** acceptable as a means of pre-filing.

### Filing Fee

There will be No Required Fee to participate in the Charlotte County Republican Committee Mass Meeting. There is a membership fee of \$10.00 per year to become a member of the Charlotte County Republican Committee. A mandatory \$10.00 registration fee will be required to participate in the 5th Congressional District Convention. Individuals seeking to prefile to become a delegate to the 5<sup>th</sup> District Congressional Convention may contact Anthony Pasciuta Jr. for the delegate forms by calling 434-568-6208.
