

OFFICIAL CALL
Mass Meeting
of Bland County Republican Committee
of the Republican Party of Virginia

As Chairman of the Bland County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Jack R. Morgan do hereby issue this call for a Mass Meeting to be held at the Bland county Courthouse, Courtroom, located at 612 Main St., Bland Virginia, starting at 6:00 PM local time on March 18th, 2010 for the following purposes:

1. Electing up to 70 Delegates and an equal number of Alternates to the Republican Party of Virginia 9th. District Convention to be held at the Fort Chiswell High School, #1 Pioneer Trail, Max Meadows, VA. 24360 on May 22nd. 2010, 10AM EDT for the purposes of electing a Congressional District Chairman and nominating a Republican candidate for the House of Representatives. Each unit is entitled to one (1) Delegate Vote per (250) Republican votes for Governor and President at their last election, so that the Bland County Republican Committee is entitled to 14 Delegate Votes;
2. To elect a unit Chairman, Vice-Chair, Treasurer and Secretary for the Bland County Republican Committee

And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates and Delegates may register at the meeting or pre-file between March 11th, 2010 and March 18th, 2010 before 6:00 p.m., or the Candidates and Delegates may just register at the Mass Meeting. Prefile forms must be received by Mar. 18th, 6:00PM and postmarks do not govern.

Prefiling/Registration Fees

There is no fee to participate in the Mass Meeting. Every person elected as a delegate or alternate to the Ninth District Convention will be asked to pay a voluntary \$5.00 fee. This voluntary fee will be paid either to the unit represented and the unit will forward it to the Ninth District Committee, or the fee will be payable by the individual at the Convention during registration.
