

OFFICIAL CALL  
Mass Meeting  
of Bath County Republican Committee  
of the Republican Party of Virginia

As Chairman of the Bath County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Andrew Jones, do hereby issue this call for a Mass Meeting to be held at the Bath County Library, Courthouse Hill Rd, Warm Springs, VA, starting at 6:30 p.m. local time on March 25, 2010, for the following purposes:

1. Electing up to 40 Delegates and an equal number of Alternates to the Republican Party of Virginia 6th Congressional District Convention to be held at the Townes Alumni Center, Liberty University, 1971 University Blvd, Lynchburg, VA at 10:00 a.m. on May 22, 2010, for the purpose of electing a 6<sup>th</sup> Congressional District Chairman. Each unit is entitled to one (1) Delegate Vote per (250) Republican votes for Governor and President at their last election, so that Bath County is entitled to 8 Delegate Votes;
2. To elect a unit chairman, vice-chairman, treasurer, secretary and members to the unit committee

And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election for Unit Chairman, Officers, Committee Members, and for delegate or alternate delegate to the 6<sup>th</sup> District Convention shall file a written statement by mail to Andrew Jones, Chair, P.O. Box 132, Wam Springs, VA 24401, which must be received by March 19, 2010. Postmarks shall not be considered. An official filing form can be obtained at [www.bathrepublicans.org](http://www.bathrepublicans.org) or by calling 540-996-4422.

If no more than one candidate files for election to any office to be voted upon at the Mass Meeting, that candidate will be declared elected. No nominations shall be accepted from the floor of the Mass Meeting.

Delegate/Alternate Delegate to the 6<sup>th</sup> District Convention - \$20 registration fee (voluntary).

There will be no registration fee to participate in this Mass Meeting.
