

## **OFFICIAL CALL**

### **Mass Meeting of the Campbell County Republican Committee of the Republican Party of Virginia**

As Chairman of the Campbell County Republican Committee of the Republican Party and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Gene Smith, do hereby issue this call for a Mass Meeting to be held at the Board of Supervisors Room, Haberer Building, Courthouse Square, Rustburg, VA on Thursday, 8 April, 2010, starting promptly at 7:00 pm for the following purposes:

1. Electing up to 290 Delegates and an equal number of Alternates to the Republican Party of Virginia Fifth Congressional District Convention to be held on Saturday, 1 May 2010 at Hampden-Sydney College, John's Auditorium, 80 College Road, Hampden-Sydney, VA 23943 beginning at 11:00 am with registration beginning at 9:30 am for the purpose of electing a Congressional District Chairman. Each unit is entitled to one (1) Delegate Vote per 500 Republican votes for Governor and President at their last election, so that the Campbell County Republican Committee is entitled to 58 Delegate Votes.
2. To elect a Campbell County Unit Chair and members to the Campbell County Unit Committee.

And for the transaction of such other business as may properly come before the mass meeting.

#### Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective elections districts.

#### Filing Requirements

Candidates for election for Unit Chairman, Members of the Campbell County Republican Committee, or as a delegate or alternate to the Fifth District Convention at said mass meeting shall file a written statement by mail or in person, to Margaret Vaughan, 9784 Village Highway, Apt. 2, Concord, VA 24538, phone: 434-942-4100 which must be received no later than Thursday, 1 April, 2010 , 6:00 pm and accompanied by any fees as noted below. Postmarks do not govern.
