

OFFICIAL CALL  
Mass Meeting of  
Charles City County Republican Committee  
of the Republican Party of Virginia

As Chairman of the Charles City County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Patricia Meyer, do hereby issue this call for a Mass Meeting to be held at Charles City County Social Center, 8320 Ruthville Rd., Charles City, VA. 23030, starting at 7:00 pm local time with registration from 6:30 to 7:00 pm. on April 6, 2010 for the following purposes:

1. Electing up to 45 Delegates and an equal number of Alternates to the Republican Party of Virginia 3rd District Convention to be held at the Hilton Garden Inn, 441 International Center Dr., Sandston, VA on May 22, 2010 at 1:00pm for the purposes of electing a Congressional District Chairman, and a Republican candidate for the House of Representatives. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Charles City is entitled to 9 Delegate Votes;
2. To elect a unit chairman, 1st Vice Chair, 2nd Vice Chair, Secretary, Treasurer and members to the unit committee.

And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election for Unit Chairman, Members of the Charles City County Republican Committee, or as a delegate or alternate delegate to the 3rd District Convention at said mass meeting shall file a written statement by mail or in person, to **Jay Templin at 9020 Ruthville Rd, Charles City, VA 23030, phone 829.6236**, which must be received not later than **5:00 pm on Tuesday, March 30, 2010. If no more than one candidate files for election to any office to be voted upon at the mass meeting, that candidate will be declared elected. If fewer than the maximum number of Delegates that Charles City County is entitled to is received at the District convention pre-file, then all properly prefiled candidates shall be deemed elected.

*There will be NO registration fee to participate in this MASS MEETING but dues to become a member are \$15 per person annually payable to CCCRC.*
