

OFFICIAL CALL
Mass Meeting
Of Cumberland County Committee
of the Republican Party of Virginia

As Chairman of the Cumberland Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Carter Harrison, do hereby issue this call for a Mass Meeting to be held at Cumberland County Courthouse, check-in will start at 6:30 P.M. and the meeting starting at 7:00 P.M. local time on March 29th for the following purposes:

1. Electing up to 40 Delegates and an equal number of Alternates to the Republican Party of Virginia Fifth Congressional Convention to be held in Hampden Sydney College, Johns Auditorium, Hampden Sydney, Virginia on May 1, 2010 at 11:00 am for the purposes of nominating a District Chairman. Each unit is entitled to one (1) Delegate Vote per (500) Republican votes for Governor and President at their last election, so that Cumberland County Republican Committee is entitled to 8 Delegate Votes;
2. To elect a unit chairman, vice-chairman, treasurer, secretary and members to the unit committee;

And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election for Unit Chairman, Members of the Cumberland County Republican Committee, or as a delegate or alternate delegate to the Fifth District Convention at said mass meeting shall file a written statement by mail or in person. Filing is satisfied by a letter or e-mail stating your intentions of seeking nomination and must include: Office sought, date, printed name; address, phone number, to Chairman, Carter Harrison. They are to be received by the Chairman at carter_harrison@yahoo.com or P.O. Box 22; Cartersville, VA 23027 to, by March 22nd and accompanied by any fees as noted below.

If no more than one candidate files for election to any office to be voted upon at the mass meeting, that candidate will be declared elected. If fewer than the maximum number of Delegates that the Cumberland County Republican Committee is entitled to at any District Convention prefile, all properly prefiled candidates shall be deemed elected.
