

**AMENDED OFFICIAL CALL**  
Legislative District Party Canvass of the 26<sup>th</sup> HOUSE  
District of the Republican Party of Virginia

As Chairman of the 26<sup>th</sup> House District Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Joel Hensley, do hereby issue this call for a Legislative District Party Canvass to be held at **Lacey Springs Elementary School**, 8621 North Valley Pike, Harrisonburg, VA 22802 and **Keister Elementary School**, 100 Maryland Avenue, Harrisonburg, Virginia 22801 from 4:00 pm to 8:00 pm local time on April 20, 2010 for the purposes of: nominating a Republican candidate for the office of DELEGATE to be voted for in the SPECIAL election in the 26<sup>th</sup> House District. **Qualified voters in the City of Harrisonburg are required to vote at Keister Elementary School and qualified voters in the 26<sup>th</sup> District portion of Rockingham County are required to vote at Lacey Spring Elementary School.**

Qualifications for Participation in the Canvass

All legal and qualified voters of the 26<sup>th</sup> HOUSE District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. A voter will be required to present a government issued photo identification or a valid Virginia voter registration card at check in.

Registration Fee

There will be no registration fee to participate in this canvass.

Candidate Filing Requirements

Candidates for the Republican nomination at said canvass shall file a written statement by mail or in person, to Joel Hensley, P. O Box 1413 or 2 S Main Street, Suite 402, Harrisonburg, Virginia 22803, which must be received not later than 12:00 pm (noon) April 10, 2010. This statement must be accompanied by a \$700 filing fee made payable to the Rockingham County Republican Committee and an affirmative declaration of their intent to support all of Republican Party nominees for public office in the ensuing election. If only one candidate properly files, then said candidate shall be declared the Republican nominee and no canvass will be held.
